13. Habitat: Residential yard, hummingbird flowers & feeders
14. Behavior (flying, feeding, resting, etc. - include and stress any habits used in identification): Compared with Rufous hummer present in garden. Was successfully defending territory with Rufous. Actively fed on numerous flowers, mostly Pineapple Sage and Turks Cap.

Include if possible: total length or relative size compared to other species present or familiar species; body bulk; shape, bill, eye, leg and plumage characteristics. Stress features that separate it from similar species:

Slightly larger than Rufous compared at close range when perched and fighting. Chunky appearance, straight black bill equal to length of head. Blue green back, top of head to tail feathers. Large rose-red gorget patch in center of throat. Grey on breast and belly turning to dark green on sides and under tail coverts. Wide tail feathers - green at base 3/4 then black with wide white tail spots. Eye and legs dark. Wings dark.

Broad tailed eliminated by lack of rufous in any plumage dark under tail coverts and call note.
Calliope eliminated by larger size and lack of rufous-call notes.
Ruby-throated & Bl. Chinned by chunky size, rose-red gorget, call notes.
