- 8. Other observers who independently identified the bird(s): Originally discovered by local homeowners in October 2017? But not reported to other local birders until mid-March 2018, m. ob. since 18 March through mid-April (11 April fide M. Brady and O. Johnson).
- 9. Light conditions (position of bird in relation to shade and to direction and amount of light):

Clear sky with optimal late morning/ midday sunlight. Sun angle high. Backlighting or glare not problematic.

- 10. Optical equipment (type, power, condition): Zeiss Victory FL 8x42, Canon Powershot HS 110 digital elph point-and-shoot camera (equipment in excellent condition).
- 11. Distance to bird(s): within 20-25 meters
- 12. Duration of observation: ~15-20 min.
- 13. Habitat: Heavily disturbed, old growth, bottomland hardwood forest, sct. native and exotic trees + shrubs + veg., well-manicured short-grass lawns, elaborate garden/ flower beds, ornamental decorations, suburban residential, etc.
- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation):

First observed foraging in short-grass lawn and front garden bed of 1997 Longwood Dr. private residence on the corner lot. Foraging and making short flights across the front garden beds toward Woodside Dr. Observed in flight multiple times but briefly. Remaining silent throughout my encounter.

15. A medium-sized to large pale, dull brown thrasher with solid brown upperparts and paler, spotted underparts. More densely spotted on breast sides and blending into brownish flanks. Whitish malar marks and throat on otherwise brown face and head. Dark moustachial/submoustachial markings bordered by white on malar and throat. Faint, non-descript pale wing bars obscured by retained(?) juvenal plumage and flight feathers. Noticeable white tail spots distally. Relatively long, slightly decurved black bill. Grayish-flesh legs and feet. Bright yellow irides with dark blackish pupil.
