- Light conditions (position of bird in relation to shade and to direction and amount of light): About one hour before dark. We observed the bird from Charlie Lyon's boat. Lighting was very good at that time. However, we had problems with the motor for about 20 minutes and could not pursue the bird immediately. When the motor was restarted, we found the bird near the middle of the lake. We followed it taking pictures (me) and video (Charlie). There was still sufficient light for both pictures and video.
- 10. Optical equipment (type, power, condition): I had Lica 10x40 binoculars
- 11. Distance to bird(s):

  I estimate that the closest we were to the bird was about 50 feet. Of course, it didn't remain that close.

- 12. Duration of observation:
  About one hour, but about 20 minutes of that time, it was very far away because of the motor problems.
- 13. Habitat:
  Cross Lake, in the City of Shreveport. Urban areas nearby. Piers and boathouses near the edge of the lake.
- Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation):
   Bird was observed sitting on the water and diving in search of food. It probably spent as much time underwater as on the surface. We never observed it flying.
