1. English and Scientific names: *Audubon's Shearwater*, *Puffinus lherminieri*
2. Number of individuals, sexes, ages, general plumage (e.g., 2 in alternate plumage): *One individual; photos do not show spread wing clearly--secondaries and upper secondary coverts appear old, but primary molt status unclear.*
3. Locality: Parish: *Gulf of Mexico (nearest parish = Plaquemines)*
Specific Locality: *28.5233, -88.8410 = ca. 37 mi SE of Miss. River South Pass jetty)*

9. Light conditions (position of bird in relation to shade and to direction and amount of light): Bright, sunny, clear sky.
10. Optical equipment (type, power, condition): Swarovski 8x30 binos (good condition), Nikon AF-S 300 mm 1:4 D camera lens (good condition)
11. Distance to bird(s): relatively close, at least when flushed, probably in the 50-80 m range, based on photos
12. Duration of observation: at least 40 sec, based on photo timestamps
13. Habitat: sargassum line, blue water
14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): I don't recall exact circumstances, but, based on photos, we first had this bird on the water, where it appears to be eating something (our popcorn?). The bird allowed relatively close approach, and then flushed.
15. Description (include only what was actually seen, *not what "should" have been seen*; include if possible: total length/relative size compared to other familiar species, body bulk, shape, proportions, bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species): Small shearwater with medium length, slender, grayish bill, contrasting blackish above and white below--except for blackish undertail coverts. Upperparts uniformly sooty grayish-black crown, nape, back, and upper tail. Upper wing also uniformly dark, but appear at least somewhat variable due to wear and molt (but clear photo of upperwing not available). Auriculars mostly white. (White above eye, if present, not apparent in photos.)
16. Voice: Not vocal
17. Similar species (include how they were eliminated by your observation): Manx Shearwater eliminated by dark undertail coverts, and mostly white auriculars.
