- 14. Habitat: Cultivated back yard w/feeders, birdbath and native plants. Property backs up to what is referred to as the "accidental forest", which is an area that is a protected chunk of successional forest near the Dillard campus in New Orleans.

Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Bird was casually feeding at regular intervals, then perching in nearby trees, often flying quite close to us. A few times it perched in a limb very close to my face, less than 5 feet away. However, it did not seem to be exhibiting territorial behavior, just fairly normal feeding and perching for a hummingbird.

Base of bill and lower mandible red, with a darker coloration on top towards the tip. Bird was slightly larger than nearby RTHU, and more brilliantly colored. Wings noticeably long and dark. Back was iridescent green with iridescent blue showing on forehead and throat. White malar stripe and white eyebrow.

- 17. Voice: Call reminiscent of a RCKI, sharp staccato calls before it would fly in to feed.
- 18. Similar species (include how they were eliminated by your observation): I was actually expecting a buff-bellied hummingbird as I was told that's what is was before I went to visit the bird. However, I do have experience with BBEH and this bird did not fit that description. It had blue on throat and forehead as noted in description, instead of the green that would be seen on a BBEH. Also, the base of bill is indeed broad unlike other hummingbirds. Nothing else in this range is similar as far as I am aware.
