13. Habitat: Neighborhood subdivision, mixed woods, shrubs, bird sitting in Vitex tree, bird feeders, drainage canal
14. Behavior of bird/circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Perched, resting.

Description (include only what was actually seen, <i>not what "should" have been seen</i> ; include if possible: total length/relative size compared to other familiar species, body bulk, shape, proportions, bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species): Grosbeak-type passerine (about 8" long) with heavy, thick bill, black & white facial pattern, with strong cinnamon-orange throat, breast & belly. Seen from front. Bird faced me and turned head to either side revealing dark/white/dark/white facial pattern of an immature. The large amount of cinnamon-orange color on it's front/underside ruled out Rose-breasted Grosbeak. No streaking. Bill was bi-colored with upper bill dark and lower somewhat lighter.
16. Voice: None heard.
17. Similar species (include how they were eliminated by your observation): Rose-breasted Grosbeak is the only other species remotely similar, but the heavy orange/cinnamon color with no visible streaking ruled out that species. Also the bi-color bill was distinctive.
