I played tape in the marsh area between the beach and Brossard Beach road. After multiple attempts I eventually had a bird respond with typical call. Kee-kee-do. It only called twice. I stayed around and played tape more but no subsequent response. This was well west of the usual access road to the beach. The bird was not seen. This is a different location than where the birds were reported in 2013 and fall of 2016 (near the rusty tricycle).
