**Mostly clear sky with optimal early AM sunlight. Sun angle fairly high at time of observation. Backlighting or glare not problematic.**
10. Optical equipment (type, power, condition): **Zeiss Victory FL 8x42, Canon Powershot HS 110 digital elph point-and-shoot camera (equipment in excellent condition).**
11. Distance to bird(s): **within 75-100 meters**
12. Duration of observation: **~1-2 min.**

13. Habitat: **Open, relatively shallow freshwater/ brackish lake with numerous concrete, metal, and wooden structures.**

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation):

**All four individuals were only observed in flight, wingtip-to-wingtip, as a single group. First observed flying in from the west, relatively low (<20') over water's surface, towards the Causeway bridge southbound span. Presumably perching on or below the bridge. Not observed continuing off to east. Relatively brief encounter considering multiple passes northbound and southbound on Causeway bridge.**

Stress features that separate it from similar species):

**A medium-sized solid with slender body, proportionately long, pointed wings, overall dark brown plumage, and long tubular bill. Solid medium-dark brown head and upperparts. Brown head and throat contrasting sharply with bright white underparts from breast down to vent (dirty to smudgy pale, mottled white-brown belly on younger individuals). Prominent yellow-flesh facial skin (grayish-blue on juvenile). Pale horn-yellow bill. Dark irides. Legs and feet not visible.**

16. Voice: **Silent.**

**Unmistakable. No other similar N.A. sulids.**
