- 1. English and Scientific names: Brown Booby, Sula leucogaster
- 2. Number of individuals, sexes, ages, general plumage (e.g., 2 in alternate plumage): 1 individual, unknown sex and age. Plumage: dark head, back, and wings with stark white belly
- 3. Parish: Saint Charles Parish
 Specific Locality: On a piling in Lake Pontchartrain just north of I-10 at the Bonnet
 Carre Spillway
- 4. Date(s) when observed: November 29, 2015
- 5. Time(s) of day when observed: Approximately 5PM
- 6. Reporting observer and address: Crystal N. Johnson, 9258 Boone Dr., Baton Rouge, LA 70810
- 7. Other observers accompanying reporter who also identified the bird(s): Jim Boutte
- 8. Other observers who *independently identified* the bird(s): Jim Boutte
- 9. Light conditions (position of bird in relation to shade and to direction and amount of light): There was no shade, and no discernible shadows, but twilight was starting, and the sun was low in the sky.
- 10. Optical equipment (type, power, condition): Bare eyes (though I have 20/15 vision, which means I can see well from afar)
- 11. Distance to bird(s): Approximately 100 feet?

- 12. Duration of observation: 5 seconds?
- 13. Habitat: Wooden piling sticking out of Lake Pontchartrain
- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Perched on a piling sticking out of Lake Pontchartrain
- 15. Description (include only what was actually seen, *not what "should" have been seen;* include if possible: total length/relative size compared to other familiar species; body bulk, shape, proportions; bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species, *or for species that are known to hybridize frequently, stress features that help eliminate possible hybrids*): I could tell the bird was large because it was perched on a piling next to a piling on which a Brown Pelican was perched. I knew that it stood out as different because it resembled a penguin with poor posture and a large rump. Its wings, back, and head were dark, and it had a white belly, with a light-colored bill. I fully admit that I would not have identified that bird as a Brown Booby without the numerous other previous reports, but I also admit that I would have immediately recognized that this bird was different from the other usual suspects because I have 20/15 vision and can see well from afar.
- 16. Voice: Unknown
- 17. Similar species (include how they were eliminated by your observation): Cormorants, gulls, and terns. I ruled out cormorant because the posture and head shape were wrong and because the white on the front was so stark and bright. I ruled out gull or tern because of the large size and because the bill seemed to extend onto the face like a mask.
- 18. Photographs or tape recordings obtained? (by whom? attached?): No
- 19. Previous experience with this species: None. Based on others' previous reports of Brown Boobies in that area, I'd searched several times while driving and riding as a passenger over I-10 near the Bonnet Carre Spillway, with no luck until yesterday.
- 20. Identification aids: (list books, illustrations, other birders, etc. used in identification):
- a. at time of observation: Consultation with Jim Boutte, the vehicle's driver, who agreed that it was a Brown Booby
- b. after observation: Consultation with my iBird app (Android) and with Jim Boutte, the vehicle's driver, who confirmed after viewing several images online that we saw a Brown Booby, although admittedly for a shorter time because he was the driver yesterday.
