I was encouraged to send you the details of a Brown booby sighting in south Lake Charles from friends who are active birders who say this bird is unusual in our area. I first saw this bird on the deck of our tugboat after having tied up at the dock about an hour previous. We all agreed it must be a seabird, but one we never saw before. At first I thought it must have flown down from one of the ships we docked earlier that morning, but not seeing it on deck on my first round immediately after tying up, now I'm not so sure. It was a friendly bird and let us walk right up to it. We set it on the dock and after awhile, it took to the air. The engineer saw it early the next morning too, perched on the bollard on the dock. - 12. Duration of observation: 1.5 hours
- 13. Habitat: Coastal river / waterway in industrial area near marsh and Calcasieu Lake
- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Resting, walking, resting, awkward long takeoff, flying, diving in water. Bird was first observed on the deck of our tugboat at the dock. It let us walk right up to it and kept looking up like it wanted to fly but couldn't. We eventually picked it up and put it on the dock and after perching on our mooring line for a while, it took off running and flapping and took to the air. Came back around in flight several times right over our heads and dove into the water.

Very yellow feet and off-white bill that was more yellow close to the face.
