Head, breast and undertail coverts orangish yellow, with sooty colored smudging on crown and behind eye. Lore blackish, connecting with black chin and bib. Belly light gray, wings dark gray with one wide and one narrow white wingbar.

- 17. Similar species (include how they were eliminated by your observation): Distinguished from imm. Baltimore by dark lores, chin and bib, gray belly and serrated appearance of upper wingbar.
