9. Light conditions (position of bird in relation to shade and to direction and amount of light): Good lighting from behind, autumn sun

10. Optical equipment (type, power, condition): Zeiss 10s, Nikon Fieldscope II 20-60x (including filming through with Samsung S8 cellphone camera), Nikon D3300 with 200 mm lens

11. Distance to bird(s): Probably down to about 40 yards

12. Duration of observation: Over an hour altogether, I'd say.

13. Habitat: Beach

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Resting in flocks of several hundred birds including Herring, Ring-billed, Lesser Black-backed, Laughing, and Franklin's gulls, and several tern species. Flew a few times at approach of vehicle.

15. Description: Adult or near-adult "White-headed" gull with slightly darker mantle than Herring Gull (perhaps with more of a blue-gray tone), yellowish legs, dark eye, and "red" and black markings on bill.

Upperparts: Color slightly darker than 100s of Herrings with it, but only noticeable in certain angles or when consciously comparing. Mantle may have had a different, bluer-gray rather than silvery-gray tone.

Folded primaries blackish with white tips visible on exposed tips. Tertial crescent white; not notably extensive-seemed smaller than on Herrings.

Head: White ground color, hood of fine, grayish or brownish streaks from about eye level back, continuing onto neck where densest in rear as hind collar, sparser on neck sides onto throat. Fore part of face white, encircling bill broadly and onto chin. Eve dark, seemed small. Bill clear pale straw color for basal 2/3, with irregular partial blackish ring just past gonys, boarder on lower mandible, narrowing on upper mandible by encroachment of yellow cutting edge. Orange smudge proximal and adjacent to black bill markings on lower mandible. Tip of bill seemed paler, but whether that was real or perception relative to dark area uncertain.

Underparts white except for gray barring on breast marking end of hood.

Legs and feet including webs pale yellow, with grayish or greenish cast n some light angles.

Open wings typical overall to other white headed gulls: gray overall with white trailing edge to secondaries and inner primaries. Black on outer 6 primaries: small chevron of black on p5 between white tongue and tip, broader black band separating white tip and tongues on p6 and p7, extensive black running along about half of p8 from gray base to white tip, p9 mostly black with white tip and small white subapical spot, p10 mostly black with long clean white tip.

Tail white with small subterminal spots composed of tiny speckles or vermiculation on outer rectrices. One central rectrix with broad black smudge streak streak running down its center.
