Specific Locality: Beach side ditch of Sarasota Drive, east side ditch of Gulf View Drive, and SW corner of BRAS Peveto Woods Sanctuary

- 9. Light conditions (position of bird in relation to shade and to direction and amount of light): Good
- 10. Optical equipment (type, power, condition): Swarovski EL 10x42
- 11. Distance to bird(s): initially just a couple feet when flushed and about 25 feet away when perched

- 12. Duration of observation: A total of four short observations lasting only seconds, the first three consisting of short flights low to ground and final observation of bird perched in shrubs about 3-4 feet above the ground. Initially, bird flushed from short, thick beach dune vegetation growing in roadside ditch on south side of Sarasota Drive while our group was walking along road. Walked over to the bird's location and it then flew into the same type of vegetation growing in the ditch along the east side of Gulf View Drive just north of Sarasota Drive. Our group played various sparrow calls/songs getting no response from the bird. Finally, when a Lincoln's Sparrow song was played the bird went up to the top of the low-growing vegetation, dropping back down briefly before flying over to the south side of the Peveto Woods just east of Gulf View Drive. Was able to view the bird in the open for several seconds at a couple of different perches about 3-4 feet above the ground before it went low into the vegetation.
- 13. Habitat: Open beach scrub/dune
- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Only observed for 3 short flights and for several seconds perched in thick brush/shrubs. Bird stayed concealed in short beach dune scrub.
- 15. Stress features that separate it from similar species, *or for species that are known to hybridize frequently, stress features that help eliminate possible hybrids*): Small sparrow that had an overall brownish or tan color, some streaking on the crown, relatively small bill and pale, but noticeable eyering.
