Stress features that separate it from similar species): Saw-billed duck with dark reddish head and white underparts, showing a sharp demarcation between reddish neck and white upper breast, longer feathers on back of head giving a more disheveled appearance than RBME, white chin, gray back with paler gray mottled flanks, red bill thicker at the base than the adjacent RBME, the bird was overall larger than the adjacent RBME

17. Similar species (include how they were eliminated by your observation): RBME eliminated by sharp demarcation between neck and breast along with white chin and other features stressed above.
