Stress features that separate it from similar species): Large buteo. Back streaky and its namesake color. Long gape. Reddish (rusty-chestnut) feathered "leggings. Shorter feathering all the way down the legs, contrasting with the yellow toes. In flight mostly whitish underneath except for the Vee formed by reddish leg feathering, a few dark marks on underwings, especially black commas near bend of wings. Above bold white flash in primaries and tale somewhat pinkish.

- 17. Similar species (include how they were eliminated by your observation):Plumage characteristics, feathered tarsi and long gape are distinctive in eliminating Red-tailed and Rough-legged among others
- 18. Photographs or tape recordings obtained? (by whom? attached?): This bird and two other immature FEHAs were present for several days and were photographed. I am enclosing two photos of this bird perched; was unable to get flight shots
