10. Optical equipment (type, power, condition): Nikon D500 with Nikon 300mm lens and Nikon 1.4 converter.

11. Distance to bird(s): 25 feet

12. Duration of observation: less than 30 seconds was able to get three photos before it flew.

13. Habitat: Low scrub and tangles in open areas of pecan trees.

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Only perched and facing me.

Stress features that separate it from similar species, *or for species that are known to hybridize frequently, stress features that help eliminate possible hybrids*): First noticed that this bird was a bit larger than the white-throated and white-crowned sparrows it was associating with. All I could see was it's breast, feet and head which had a gold/yellowish crown in the middle of the head, bordered by a slight black strip. The breast appeared darker because it was in

the shadow of a large pecan tree and "splotched" with a faint streak along the outer edge of the breast.

17. Similar species (include how they were eliminated by your observation): Checked for winter plumage of Swamp, White-crowned, White-throated and other common winter sparrows. Could not find any plumages that matched what I saw.

a. at time of observation: I wasn't sure what it was but was confident it was a sparrow I've never seen before. Initially didn't Golden-crowned as to the rarity of such a sight.
