11. Distance to bird(s): I honestly couldn't gauge the distance...several hundred feet in the air, I imagine.

12. Duration of observation: ca. two minutes

13. Habitat: open sky

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): soaring on flat (versus dihedral) wings, steady...never flapping.

Description (include only what was actually seen, *not what "should" have been seen;* include if possible: total length/relative size compared to other familiar species; body bulk, shape, proportions; bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species, *or for species that are known to hybridize frequently, stress features that help eliminate possible hybrids*): Large dark chocolate raptor with a rich, golden nape and patagials. Tail was dark, no white detected, although I was not satisfied with the scrutiny I obtained. Soft parts (i.e. cere, feet) were yellow (could not see tarsi, obviously). This bird was big-headed, but not to the extreme as in *Haliaeetus leucocephalus*. Much larger and flatter-winged than any dark *Buteo* (or *Geranoaetus albicaudatus*). Vultures of both species were readily eliminated by cere color and (especially *Cathartes aura*) soaring on flat wings. Primaries, secondaries (inner and outer) were slightly lighter brown.
