10. Optical equipment (type, power, condition): Alpen Rainier 8x42 binoculars in very good condition. Swarovski EL 12x50 bins, a week old. Nikon P900 camera.

11. Distance to bird(s): Very far, about a half mile.

12. Duration of observation: 3 minutes or so.

13. Habitat: Bird was soaring/circling/moving south along easternmost treeline. Between us and the treeline, it's all open ag fields with ditches/levees and a large flock of mixed ducks and geese.

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): See previous answer.

Wings in slight dyhedral. Tail wedge shaped with prominent white band across base on upper side. Paler nape; pale strips on upper sides of wings from "wrist" diagonally to body. No mottled spots or streaks seen anywhere (as in subad. BAEA). No white patches on underside of wings seen (as in juv. GOEA), although photo only shows upperside.

17. Similar species (include how they were eliminated by your observation): TUVU eliminated by presence of large white band across base of tail. Adult BAEA eliminated by absence of white head and white tail. Subad. BAEA eliminated by lack of mottled/ streaked plumage and white band across tail.
