9. Light conditions (position of bird in relation to shade and to direction and amount of light): Light conditions good. Bird ~300m due W of me with sun directly above me. Not backlit.

10. Optical equipment (type, power, condition): Binoculars - Swarovski 10x50 EL in good condition. Camera - Canon EOS D7 with 100-400 zoom lens in good condition.

11. Distance to bird(s): ~300m

12. Duration of observation: ~2 minutes

13. Habitat: Predominantly rice fields.

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Bird initially noted to be soaring on thermals loosely in vicinity of similarly soaring TUVUs. It caught my attention as it was notably larger than TUVUs, did not rock when soaring and had less of a dihedral than TUVUs. Initially the bird was heading due S at which time vI was fortunate to get a picture. It then slowly turned to a W heading and slowly moved out of sight. I tried unsuccessfully to relocate bird.

White patches at the base of the flight feathers with white at the base of longish narrow tail anterior to definite widedark terminal band. Bulging secondaries noted.

BAEA: Mature adult with all white head and tail & larger yellow bill. Immature birds with longer neck, larger bill as well as white patches on body and other parts of wings.

TUVU: Differences as above also head is smaller and reddish.

BLVU: Shorter tail and neck with tendency to flap frequently.

All other raptors are substantially smaller.
