13. Habitat: backyard with large oak tree and several smaller trees, multiple feeders present with various feed types

Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): first seen on top of black oil sunflower seed feeder. He sat perched there for a few minutes then started eating seed. He flew up into oak tree for a few minutes then flew back down to same feeder. Repeated this a few times and then flew onto nyjer seed feeder. After eating for a few minutes he flew back up into oak tree and sat perched for a while before flying off.

Typical seed eating conical bill with darkish area noted on top of bill. No distinct wing bars visible but has some patches of white on wing are.
