- 8. Other observers who independently identified the bird(s): Discovered by Michael Autin (31 January 2018, I think); subsequently seen by many
- 9. Light conditions (position of bird in relation to shade and to direction and amount of light): Birds were generally out in the open, beneath an overcast sky, 15-45 min after sunrise; so not bright, but "good" ambient light
- 10. Optical equipment (type, power, condition): Swarovski 8x30 binos (good condition), Nikon AF-S 300 mm 1:4 D camera lens (good condition), Pentax PF-80EDa spotting scope (good condition)
- 11. Distance to bird(s): 25-35 m

- 12 Duration of observation: 40 min
- 13. Habitat: ditch receiving water from culvert beneath road and adjacent wooded bank, bordering freshwater marsh (south end of Lake Houma)
- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): foraging, for the duration of the observation; eating, among other things, apple snails
- 15. Description (include only what was actually seen, *not what "should" have been seen;* include if possible: total length/relative size compared to other familiar species, body bulk, shape, proportions, bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species): Wading bird, close to ibis in size and general proportions, brown body/wings w/ white spotting on back, upper wing covs, and breast. Neck paler, more evenly and finely streaked white. Bill only slightly decurved and mostly orange-horn w/ dark culmen and mandible tip. Legs dark gray.
- 16. Voice: Called once (unsolicited): a shrill, relatively high-pitched, but "thick," rising and falling scream.
- 17. Similar species (include how they were eliminated by your observation): Immature White Ibis superficially similar, but easily distinguished by this bird's overall brown plumage with white spots, and straighter, more horn-orange colored (not reddish orange) bill. Immature night-herons also easily eliminated by bill shape and color. All of those species also eliminated by voice.
