9. Light conditions (position of bird in relation to shade and to direction and amount of light): Overcast sky, Bird was standing in reeds and also in very shallow water. Lighting was fair, no direct sunshine.

10. Optical equipment (type, power, condition): Lumix F28 25-600 mm lens. Steiner 8x42 binoculars.

11. Distance to bird(s):30-45 feet

12. Duration of observation: approximately an hour.

13. Habitat: shallow, marshy fresh water. Connected to Lake Houma.

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): resting and feeding. Hiding in tall reeds and would come out to pluck up an apple snail. A little skittish, but that was due to several observers nearby.

Chocolate brown on back and tail, with bold white spots on its back and wings. Very long bill with a slight downcurve, dark eye. Its neck was brown with white specks.
