- 8. Other observers who independently identified the bird(s): This bird was discovered three days prior by YRARF field trip participants
- 9. Light conditions (position of bird in relation to shade and to direction and amount of light): The bird was backlit when I found it, but I was able to maneuver and get the sun to my back and the bird in generally soft, but bright, light beneath thin clouds coming and going in front of the sun.
- 10. Optical equipment (type, power, condition): Swarovski 8x30 binos (good condition), Nikon AF-S 300 mm 1:4 D camera lens (good condition), Pentax PF-80EDa spotting scope (good condition)
- 11. Distance to bird(s): ca. 50 m

- 12. Duration of observation: 5 min
- 13. Habitat: open water of sewage pond
- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Initially alone w/ no other ducks nearby, diving regularly, on one of smaller SE ponds; later flew to big pond.
- 15. Description (include only what was actually seen, *not what "should" have been seen;* include if possible: total length/relative size compared to other familiar species, body bulk, shape, proportions, bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species): Small-med sized duck, w/ notably plump appearance in flight. Back and upper wing generally uniformly brownish, on water and in flight. White flanks conspicuous on water and in flight. Rel. small, dark-gray bill. Unique head pattern w/ dark brownish crown/nape and paler brownish supraloral line, lower cheek and neck contrasting w/ broad, whitish mask that tapered to a point behind eye. Immature based on Madge and Burn (1988).
- 16. Voice: Not vocal
- 17. Similar species (include how they were eliminated by your observation): A distinctive duck if seen well and at reasonably close range--as here--where unique light-dark pattern of head may be distinguished easily from other diving ducks that may have indistinct or sex/age-variable pale areas on head (e.g., Ruddy Duck, scoters, etc.). Harlequin Duck has more uniformly dark head with different light-dark pattern.
