- 1. English and Scientific names:Long-tailed duck
- 2. Number of individuals, sexes, ages, general plumage (e.g., 2 in alternate plumage): One adult female. Winter plumage, dark crown area, white face and throat/neck, dark ear smudged, small, stubby bill. Dark back and dark breast. Didn't see underside. It remained in the pond and was foraging.
- 3. Parish: St Tammany
 Specific Locality: Howze Beach, pond next to the Harbor Center.
- 4. Date(s) when observed:1-12-20
- 5. Time(s) of day when observed: 8:52, 8:54,8:55. Still in same area when we departed.

- 7. Other observers accompanying reporter who also *identified* the bird(s): Malise Prieto and Willie Mathews
- 8. Other observers who independently identified the bird(s): Wanda and Mike Beelman(found it), Jody Shugart and Claire Thomas
- 9. Light conditions (position of bird in relation to shade and to direction and amount of light): Heavy fog with a northerly wind at about 5-10 mph. Poor light.
- 10. Optical equipment (type, power, condition):10x50 Vortex binoculars and Nikon P900 camera
- 11. Distance to bird(s): 50 to 75 yards

- 12. Duration of observation: 15 minutes
- 13. Habitat: Large pond, surrounded by a levee on 2 sides, parking lot and Oak Harbor Blvd on the other 2 sides. No nearby trees.
- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation):Bird was feeding. Up for a few seconds, then would dive down for about 15 to 25 seconds. Did this frequently. Upon arrival, no one was in the huge parking lot except Willie Mathews. Very quiet with no threats for the bird.
- 15. Stress features that separate it from similar species, *or for species that are known to hybridize frequently*, *stress features that help eliminate possible hybrids*): At this distance, it appeared to be a large duck, the only other bird in the pond was a Red-breasted merganser, but not close to the duck for size comparison. Maybe about the size of a Redhead. Small stubby bill.
