First observed in very dark lighting with brief glimpses of bird, but later observed in 60% lighting in understory of oak cathedral

Binoculars: Leica Trinovid 8 x 42 Camera: Fuji X-T4 with 100-400mm Lens

11. Distance to bird(s):

15 ft

12. Duration of observation:

Total of 10 minutes; first detected by chip notes and had multiple encounters with this bird during my 3 hour 15 minute trip

13. Habitat:

Coastal Chenier; dense understory of oak cathedral

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation):

The bird was moving low through dense shrubs aggressively giving harsh chip notes; making itself visible for seconds at a time

15. Slaty gray hooded Geothlypis with BOLD white eye arcs and dark "mask", gray throated and bright yellow under belly and under tail; greenish color above

16. Voice:

Bird was aggressively giving harsh; wet chip notes

Mourning Warbler; separated by the bold; distinct eye arcs; longer tailed than MOWA; lower pitched chip notes than MOWA, but very hard for me to tell the difference
