9. Light conditions (position of bird in relation to shade and to direction and amount of light):

Mostly clear sky with optimal late afternoon sunlight. Sun angle fairly high initially but lowering to west. Backlighting or glare not problematic.

10. Optical equipment (type, power, condition): Zeiss Victory FL 8x42, Canon Powershot HS 110 digital elph point-and-shoot camera (equipment in excellent condition).

11. Distance to bird(s): within 3-5 meters from boat

12. Duration of observation: ~20-25 min.

13. Habitat: Open freshwater lake, disturbed upland mixed pine-hardwood forest, tracts of bottomland hardwood forest, cypress-tupelo swamp, manicured, short-grass lawn park, brushy edges, suburban residential, etc.

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation):

First observed flying in from the northeast with group of Ring-billed Gulls (RBGU). Initially it circled the boat several times at close range to investigate our "chumming" efforts (popcorn, bread, etc.) before it flew off and alit atop a wooden dock shelter with other roosting gulls. Upon closer approach, the boat flushed most of the roosting gulls from the structure and a majority of these individuals, including the Mew Gull (MEGU), joined in on the feeding frenzy again. Once again, the MEGU made closes passes in flight by the boat and rested on the water near the boat on multiple occasions. It remained in view up until it was nearly too dark to keep track of its movements.

15. Stress features that separate it from similar species):

A medium-sized, white-headed gull with overall smudgy white-brown, mottled plumage. Whitish, small, rounded head with dark smudges and streaking on crown and nape. Paler head and dirty white underparts contrasting with dark upperparts. Splotchy brownish hind-neck and upper breast. Medium gray scapular feathers replacing first-generation juvenal scapulars on mantle. Gray center mantle contrasting with brownish-black flight feathers on spread wing. Dark brown primaries and primary coverts. Broad, extensively dark (blackish) tail contrasting with paler, mottled uppertail coverts. Mottled, barred brownish undertail coverts. Relatively slender, parallel-sided bill lacking pronounced gonydeal angle distally. Dull flesh bill base with extensive dark tip. Proportionately large, dark, beady irides. Subtle dark markings coalescing around the eyes. Dull yellowish-horn legs and feet.

16. Voice: Generally silent.

17. Similar species (include how they were eliminated by your observation): Superficially similar to first-cycle/ first-winter Ring-billed Gull (RBGU), however, much more smudgy and darker overall. Slightly smaller with proportionately smaller, more rounded head than RBGU. Longer, more slender wings than RBGU. Darker gray mantle scapulars eliminate RBGU. Broad, solid dark terminal tail band eliminates RBGU. Slender, parallel-sided bill lacking pronounced gonys eliminates RBGU. Lack of contrasting white tail base eliminates nominate MEGU. Not similar to any other N.A. gulls.

Familiar with this species from numerous encounters in coastal zones of multiple West coast (Pacific Ocean) states from Alaska to California and British Columbia (Canada). Plus, at least one nominate adult from Massachusetts.
