- 9. Light conditions (position of bird in relation to shade and to direction and amount of light): Sunny. Bird out in the open on power lines and fences. Flying across the road between the two.

- 10. Optical equipment (type, power, condition): Opticron 10 x 50, good condition.
- 11. Distance to bird(s): Seen from across a street and sitting directly overhead on the power lines. Approx. 10ft.
- 12. Duration of observation: 45 mins.
- 13. Habitat: Cut field edged with trees and brush along fence line. Across the street from an asphalt plant.
- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Bird was seen flying from one side of the road to the other feeding and flycatching. She was not in the least disturbed by Janine and I nor the semi trucks hauling gravel and traveling in and out of the plant. We were able to get some close photos as she was not scared of us at all.

Mostly blue on rump and tail and on wing edges (flight feathers). It's beak was also very sharp and pointy. Mostly grey with a slight wash of rust under chin. White under tail.

- 17. Similar species (include how they were eliminated by your observation): Eastern Bluebird was eliminated because the bird was almost void of blue except on it's rump and flight feathers. No rose color on chest or sides. No blue on back.
