9. Light conditions (position of bird in relation to shade and to direction and amount of light): Overcast, gray, but good visibility. Bird was easily seen initially on top of tree next to road and moving onto grassy levee.

10. Optical equipment (type, power, condition): Zeiss Conquest HD 8 x 42 binoculars; Canon EOS Rebel t7i with Tamron 150-600 telephoto lens, relatively new and in great condition.

11. Distance to bird(s): From 40 to 15 yards, no obstruction.

12. Duration of observation: 20 minutes. Bird was cooperative and seen and photographed by entire party.

13. Habitat: Mixed woods on southern edge of ponds/ grassy levee at Industrial Canal, in eastern Orleans Parish.

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): The bird was initially seen atop a willow tree adjacent to the gravelled road immediately east of the pumping station at the southern terminus of Recovery Road (where the road turns east to follow the levee of the Industrial Canal). The bird was stationary for several minutes and then began to engage in typical bluebird behavior, sallying forth to the grass on the levee side of the road to feed and then returning to its perch. It remained the entire time we observed, which was about twenty minutes.

15. Description (include only what was actually seen, *not what "should" have been seen*; include if possible: total length/relative size compared to other familiar species; body bulk, shape, proportions; bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species, *or for species that are known to hybridize frequently, stress features that help eliminate possible hybrids*): Typical female Mountain Bluebird (I have seen these in the Rockies, around Pikes Peak, and Florissant Colorado, and Boulder area). Brownish, gray back, head, flanks and breast, with white visible undertail coverts, with blue wings, rump and tail. Very visible white eye ring. Thinnish black bill, dark legs and feet.

16. Voice: The bird did not vocalize while I was present.

17. Similar species (include how they were eliminated by your observation): Eastern and Western Bluebirds. Brown flanks next to white undertail coverts. Thin, longer bill, no red orange on breast. Also, the bird displayed hovering over prey at least twice.

18. Photographs or tape recordings obtained? (by whom? attached?): I took multiple photographs, along with the others in the party. No tape recordings from me.

19. Previous experience with this species: Seen in the western United States in Colorado Springs, Florissant Colorado and Boulder Colorado.
