1. English and Scientific names: Mountain Bluebird (Sialia currucoides)

2. Number of individuals, sexes, ages, general plumage (e.g., 2 in alternate plumage): one female

3. Parish: Iberville

7. Other observers accompanying reporter who also *identified* the bird(s): none

8. <u>Other observers who</u> *independently identified* the bird(s): other birders chased it next day or two; successful were J. V. Remsen, M. McClindon, D. F. Lane, and R. T. Brumfield with eBird reports from both Iberville and East Baton Rouge parishes and additional photos.

9. Light conditions (position of bird in relation to shade and to direction and amount of light): good, but glare was bad and it was difficult to get bird close enough and in good lighting for photos.

10. Optical equipment (type, power, condition): Leica binos 10 X 40 & 10 X 50, and Kowa scope with zoom eyepiece.

11. Distance to bird(s): remained fairly distant during observation as it fed in a field, closest was maybe 75-100 feet.

12. Duration of observation: about 20 minutes

13. Habitat: patch of semi-overgrown cattle pasture (along south side of Manchac Road in between Bayou Manchac and deciduous forest farther to south) with scattered chinese tallow, other shrubs and scattered small trees.

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): using small trees and shrubs as perch to sally for insects or to the ground in company of Yellow-rumped Warblers, a few Eastern Bluebirds, and Eastern Phoebe; also seen to fly to tall trees at east edge of pasture with Eastern Bluebirds and Cedar Waxwings but then returned to short trees and shrubs in field to forage.

15. Description (include only what was actually seen, *not what "should" have been seen;* include if possible: total length/relative size compared to other familiar species; body bulk, shape, proportions; bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species, *or for species that are known to hybridize frequently, stress features that help eliminate possible hybrids*): a bluebird with upright posture and dull muted plumage coloration; we were initially struck by long-winged look with wingtips extending beyond half way to the tail tip; blue in tail, brownish-gray upperparts, including back and head; rump blue-gray, wings darker with pale feather edges, pale buffy white eyering, whitish throat and belly and undertail coverts separated by buffy-brownish/hint of rust chest band; eye dark, bill, legs, feet black.
