- 9. Light conditions (position of bird in relation to shade and to direction and amount of light): Seen and photographed in good light (ie sun behind observer). Bird partially in shade.
- 10. Optical equipment (type, power, condition): Swarovski EL 10x42, new. Canon 7D Mark II with 100-400mm 4.5-5.6 lens, good.
- 11. Distance to bird(s): As close as 10 meters.
- 12. Duration of observation: <2 minutes during each of three encounters
- 13. Habitat: Wooded fence line/road side in agricultural landscape.

- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Initially seen flying off of ground away from observer into a small tree at about head height. Seen briefly in binoculars to confirm identification, but dropped out of sight while drawing camera. Did not respond to Pyrrhuloxia song, or pishing, but popped up almost immediately in response to Pyrrhuloxia chip notes at which time it was photographed. Once joined by SWC/DLD, the bird again responded to chip note recording and offered obstructed views and additional photo opportunities.
- 15. Description (include only what was actually seen, *not what "should" have been seen;* include if possible: total length/relative size compared to other familiar species, body bulk, shape, proportions, bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species): Gray cardinalid with long red tail, red in primaries, and long red crest. Short, stubby, and rounded yellowish bill.
