Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation):setting on the wall of outdoor shower, looked very fatigue and tired. Keep closing eyes for a few minutes then open. Looked to be sleeping at times. Occasionally opening mouth wide, like it was yawning and stretched out his wings open. After a hour or so it set down on fence and began to slump it's head down actually hanging it below its feet and wobbled as if it was going to fall off wall. I thought it was dying and did not want it to fall off wall, so I went up behind it to gently take it off to set on ground. Upon touching it on both sides of it's wings it picked it's head up and looked at me with a loud shrill (hard to actually describe) sound. Upon backing off and talking softly to it he or she just stared at me not scared and soon went back to closing its eyes but not hanging head any more. I went into house to download photos and about 20 minutes later came out to see if it was still OK only to find it was gone.

White under body with brown mottled feathers on top of wings, dark brown under wings. Wings very long when stretched out. Red webbed feet. Long bill pinkish color with dark tip. Blueish orbital ring and right where feathers and bill meets. Eyes were dark brown. Long primaries feathers.
