11. Distance to bird(s):

Probably 150 yards.

12. Duration of Observation:

Bird seen/heard off and on from about 9:00 AM until 10:40 AM when I left.

13. Habitat:

Impounded cypress swamp. Bird located in permanently flooded cypress groves.

14. Behavior of bird/circumstances of observations (flying, feeding, resting; including and stress habits in identification: relate events surrounding observation):

Bird was observed flying back and forth between perches across an area of about 400 yards parallel to the shore. Did not see the bird feeding. It moved several times in response to disturbances caused by a tour boat.

15. Description (include only what was actually seen, not what "should" have been seen: include if possible: total length/relative size compared to other familiar species, body bulk, shape, proportions, bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species):

I actually saw the bird in silhouette once for about 30 seconds. It was clearly a very large kingfisher with an inordinately long, robust bill. I would describe the bill as looking like a narrow bowie knife. I could not detect color, per se, but the belly was monotone supporting the color pattern of a female Ringed Kingfisher.

16. Voice:

Loud staccato rattle with no inflection in tone. Uttered when bird flew about, apparently as it departed a perch.

17. Similar species (include how they were eliminated by your observation):

Belted Kingfisher – Larger, call distinctly different, and bill disproportionately large with very different shape.

None. Remsen and Myers took photos.

19. Previous experience with this species:

Seen/heard several times in Lower Rio Grande Valley, Texas.
