- 1. English and Scientific names: Spotted Towhee (*Pipilo maculatus*)
- 2. Number of individuals, sexes, ages, general plumage (e.g., 2 in alternate plumage): 1 female-type in unknown (after-juvenile) plumage
- 3. Locality: Parish: Vermilion Specific Locality: 16.4 mi ESE of Pecan Island, Chenier au Tigre, Paul J. Rainey Audubon Sanctuary, LA
- 4. Date(s) when observed: 4 Feb 2012
- 5. Time(s) of day when observed: 8:30am
- 6. Reporting observer and address: Erik I. Johnson, 102 Goodwood Cir., Lafayette, LA 70508
- 7. Other observers accompanying reporter who also *identified* the bird(s): Melanie Driscoll spotted the bird, David J. Ringer and I then saw the bird.
- 8. Other observers who *independently identified* the bird(s): none known.
- 9. Light conditions (position of bird in relation to shade and to direction and amount of light): foggy, seen in even understory light and then more backlit as it moved up in the subcanopy.
- 10. Optical equipment (type, power, condition): 10 x 42 Swarovski EL binoculars, Nikon D100 camera with 80-400mm f/4.5-5.6 ED lens
- 11. Distance to bird(s): 8-15 meters
- 12. Duration of observation: 5 minutes

- 13. Habitat: live oak chenier in view of salt marsh and beach dunes
- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): found by pishing and screech-owl imitations, responded silently, but clearly agitated approaching observers
- 15. Description (include only what was actually seen, *not what "should" have been seen*; include if possible: total length/relative size compared to other familiar species, body bulk, shape, proportions, bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species):

Clearly a "Rufous-sided" Towhee with heavy white spotting on wing coverts and back. Iris dark (brick-reddish), dark chocolate brown (unlike paler warm tones of Eastern Towhee).

- 16. Voice: not heard
- 17. Similar species (include how they were eliminated by your observation): Eastern Towhee eliminated by extensive white spotting on wing coverts and back and lack of white mark at base of outer primaries.
- 18. Photographs or tape recordings obtained? (by whom? attached?): Yes, by EIJ and DJR.
