Front of [upper] bill slopes down, bump on lower bill is w[h]ere the spot is. Lower wing goes to white untik mostly black wing tips." This description was recorded in the field by microrecorder and transcribed into my Birdbase files. Bird did not show any stress, it ignored me.

16. Voice: Did not call

17. Similar species (include how they were eliminated by your observation): Ring-billed Gull excluded by dark iris, lack of ring on bill. Herring Gull excluded because of its larger bill, general different appearance and pale iris. Other unlikely light-gray-backed, white-headed gulls excluded (Mew Gull has yellow legs, no mark on bill) (California Gull has yellow legs, marks on both upper and low bill) (Iceland Gull, Glaucous Gull don't have enough/any black on wing tips).
