11. Distance to bird(s): first viewed on fence at about 30 ft when driving down hwy.

when approached by foot flew back into line of evergreen trees (mostly oaks) viewed for about 10-15 minutes at different locations in dense trees about 50 yards away with brief views enough to id bird as a Tyrannus flycatcher. Eventually perched on top of a deciduous tree out in open about 150 yards away and began calling.

13. Habitat: roadside, fenced area, with large tree line, beyond open grassy area .

Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): first viewed on fence at about 30 ft when driving down hwy., was flycatching from fence and then would return to fence. When approached by foot flew back into line of evergreen trees (mostly oaks) viewed for about 10-15 minutes at different locations in dense trees about 100 ft away with brief views enough to id bird as a Tyrannus flycatcher. Eventually perched on top of a deciduous tree out in open and began calling.

Mockingbird size with shorter tail. Large flycatcher with long, heavy, dark bill, bright yellow below with whitish chin and throat. Dark gray with darker gray ear patch. Back is greenish gray. Markedly notched tail.

Almost identical to Couch's kingbird, but did seem to have a longer and not as heavy bill as Couch's. Head paler gray and bill larger and longer than Cassin's kingbird. Tail paler without white edges and bill smaller than
