One winter adult.
3. Locality: Parish:Caddo

4. Date(s) when observed: 12-30-15, 1-1-16, 1-6-16, 1-13-16, 1-24-16

- 5. Time(s) of day when observed: I first found the bird around 8:30 am on 12-30-15 while doing a bird survey by boat. I saw it again on 1-1-16 by myself, and then relocated it on 1-1-16 for Jean and Jeff Trahan and Rosemary Seidler. I relocated it again on 1-13-16 and on 1-24-16 and multiple observers saw on these latter two occasions. Photos are included from the 12-30-15, 1-6-16, qnd 1-24-16 observations.
- 6. Reporting observer and address: Charles Lyon Shreveport, LA
- 7. Other observers accompanying reporter who also *identified* the bird(s): multiple observers on the 1-6-16, 1-13-16, and 1-24-16 observations.
- 8. Other observers who *independently identified* the bird(s):multiple other observers
