12. Duration of observation: ca. 3 minutes

13. Habitat: Soaring over residential neighborhood badly damaged during Hurricane Katrina, involving plenty of overgrown and open woodlots, fields, etc.

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Soaring NNW and being mobbed by American Crows.

15. Description (include only what was actually seen, *not what "should" have been seen;* include if possible: total length/relative size compared to other familiar species; body bulk, shape, proportions; bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species, *or for species that are known to hybridize frequently, stress features that help eliminate possible hybrids*): Large Buteo, head, body and marginal coverts dark chocolate (almost black, with light mottling in marginal coverts), primaries and secondaries light with dark, pronounced barring. Upper chest had an irregularly-shaped white "splash", leading towards belly. Tail light-colored with fine barring, but not pure white with subterminal band as in adults. Wings longer and appeared more narrow than in Red-tailed Hawks.

Similar species (include how they were eliminated by your observation): Red-tailed Hawk has shorter, broader wings and although many RTHAs are extremely variable, including "Harlan's", this bird possessed the typical white "splash" on the upper chest, where it is usually expected. Also, this bird had no subterminal or terminal band.

19. Previous experience with this species: I have seen this species on five previous occasions in Louisiana (both adults and immatures), as well as numerous times in south Texas.
